Section 2 Data Protection

By completing this credit application form, you the customer are providing Agriplus Ltd with your personal information, this document will outline how your information is processed, stored and where necessary, disposed of.

Information Storage and Access

1. Once an account is established or information has been taken during purchase of a tractor and or agricultural implement, all personal information is inputted onto a protected computer database.
2. A back up of this database is kept on a protected removable storage drive.
3. The paper copy of the account application and any other documentation is stored in a secure file, this file can be accessed by only one person.

Processing and Usage

1. **All** customer information is kept for account and customer service use **ONLY!**
2. At **NO** time will any customer information be passed onto any third party* without providing prior notification and obtaining prior documented consent from you the customer.

***The only times that consent would be required to pass on information to a third party would be:**

- **When applying for a credit account it MAY be necessary for Agriplus Ltd to conduct a credit check.**
- **When buying a tractor and or agricultural implement, customer information will need to be passed onto the manufacturer of the tractor or agricultural implement for warranty and service purposes.**
- **When seeking finance to buy a tractor and or agricultural implement, customer information will need to be passed onto the finance company involved.**

If it is necessary to provide customer information to a third party from Agriplus Ltd, full and detailed consent will be obtained from the customer/s along with Agriplus Ltd providing full details of the third parties requiring the information to the customer/s.

Consent

1. Consent is not obligatory and is not required to receive any of the services provided by Agriplus Ltd, should consent be withdrawn or not initially given, any business would then be conducted on a "cash" or "card" basis where personal identification information was not necessary.
2. You the customer have the right to withdraw your consent at any time, to do this simply notify Agriplus Ltd in writing either by letter or via email of your wish to withdraw consent**. ****Please note – If you hold a credit account with Agriplus Ltd and you express your wish to withdraw consent for the storage and processing of your information doing so will terminate your credit account with Agriplus Ltd.**
3. You the customer have the right to view any of your information stored by Agriplus Ltd, a request for this information can be made at any time in writing either by letter or via email to Agriplus Ltd. Once a request has been made it can take up one month for the information to be provided.
